## The Members raised the following queries:

- Will there be another Retrofit Scheme available in the future for those houses that did not qualify for the current Energy Efficiency Retrofit Scheme?
- Will the Members be given access to the portal for the new Choice Based Letting System?
- The number of housing loan applications is very low. The issue would appear to be the condition stipulating that a tenant has to raise 10% of the cost and prove a savings pattern. Can the MD write to the Department to see if these criteria can be amended to make it easier for the tenant to access a housing loan?
- When will the local authority housing on the Mill Road, Thurles and at Ned Hayes Park, Two Mile Borris be allocated?
- There appears to be very little dog control in relation to dogs roaming and continuously barking, including a report of biting, in Gortataggart housing estate, Thurles. Can the number of dogs permitted in a household form part of the tenancy agreement and a condition also be included that if a dog is removed from a household, then another dog cannot be brought in to replace it?
- In instances where the banks have repossessed private houses, the houses are left boarded up for long periods. One such house in Thurles has been boarded up for 2½ years and the grounds are overgrown with rats and mice. Can the Council purchase these properties under Compulsory Purchase Order (CPO) legislation if dereliction orders are not being dealt with by the owner?
- Council houses in Templemore are not being turned around quick enough when pre-letting works have to be undertaken.
- The unused Sacred Heart Convent building in the centre of Roscrea is in a dangerous condition. Can the Council liaise with the owner of the property to examine different potential possibilities for the building?
- There are 2 derelict buildings in Roscrea, one at the top of Limerick Street where the road had to be closed off as the building was unsafe. The second building is a couple of hundred yards down the road on the left-hand side.
- The former Grants Hotel in Roscrea is now left abandoned and in a derelict state. It would be an ideal opportunity for the MD if they could take control and develop the building.

- Tenants seeking transfers have to go through the entire process of reapplying for housing as if they were making an application for the first time, despite having previously made an application.
- How can the Council improve its turnaround time in relation to preletting repairs? The turnaround for Tipperary County Council seems quite high when compared to other Local Authorities.
- Is there a direct contact at Council level to deal with issues in relation to the Ukrainian refugees?
- There are a large number of landlords leaving the rental market. This
  is having a negative knock-on effect on the availability of HAP
  properties.

# Replies to queries raised were as follows:-

- While derelict buildings do fall under the remit of the Environment Section, Housing section do have a Vacant Homes Officer who actively engages with the banks, all derelict properties raised at this meeting will be referred directly to the Director of Housing.
- Choice Based Letting will roll out later this week with viewings on the website available by the end of the week. A letter will issue to all tenants today giving them their User ID and access to the portal. Members will also have access to the portal.
- There is a provision in the Tenancy Agreement in relation to the control
  of dogs. Community Liaison Officers work in conjunction with the Dog
  Wardens. Housing Section will examine this provision in detail and
  revert back to the MD and specifically in relation to the house in
  Gortataggart, Thurles.
- Any tenant who signs up to HAP is asked if they also want to go on the housing list and if so, their HAP application automatically includes them on the housing list. It is only those tenants who are applying for a transfer that are requested to re-apply for housing. This re-application is a Department requirement and it gives the Local Authority an opportunity to re-confirm an applicant's details.
- The Council have received 13 housing loan applications so far this year, with 4 valid applications and 5 approved applications.
- In relation to the turnaround of housing stock the Council cannot hand a house over to a tenant without undertaking works as the Council will be held liable if an issue arises. The average minimum spend for the Council to turn around a house is €7,500. Any house that requires a major refurbishment must first be approved for funding by the Department. The MD currently have 22 minor repairs and 11 major refurbishments that will require Department Approval.
- There is currently a 25-30% refusal rate across the County which is very high. It is hoped that tenants will engage with the Choice Based Letting system and it will lead to a reduction in the refusal rate.
- The Mill Road Housing development, Thurles will be allocated in 2 phases, allocation of the first phase of 14 houses will commence in April and the second phase will commence in May.

 The Ned Hayes housing development at Two-Mile Borris will be delivered by the end of October and should be up on the Choice Based Letting website in November.

- The average turnaround time for houses is currently 40 weeks. However, the average time in the County was affected considerably by the Council seeking additional funding from the Department to address works on major voids that the Council would not have been able to finance themselves. Refurbishment works on these major voids will cost between €50,000 to €70,000 per house. These major voids are skewing the average figures somewhat as the Council is obliged to take them into account when producing average returns. This year the figures should return to normal.
- The query in relation to the Retrofit Scheme will be examined and Housing Section will revert back to the MD.
- The Red Cross and IPAS (International Protection Accommodation Services) are the two bodies that are dealing with the Ukrainian refugees at a national and local level. The Council currently does not have a role to play with the refugees. It is anticipated that the hotel sector will be part of the solution for the next few months. There are currently 9,000 Ukrainian refugees in the country with a total of 140,000 expected and Local Authority participation will increase over the coming weeks and months. Further information will develop over the coming days.

## The Members raised the following issues:-

- Thurles was awarded the European Town of Sport in 2012, however nothing has ever been done to take advantage of this. There is no signage, no events and no reference to it in any leaflets or brochures. What are the plans, if any, in relation to sports tourism for Thurles?
- Following the association between Comhairle na nÓg and Jigsaw some time ago, have there been many referrals to Jigsaw?
- The criterion for CLÁR funding has changed. Previously it could have been used for speed detection signs which are no longer eligible.
- Has a location for the Bushcraft Centre been decided and when is it anticipated that the Bushcraft Centre will be complete. When will the Part 8 go to the Council for the Littleton Labyrinth?
- When is the proposed GAA tour of Thurles, to include Semple Stadium, expected to be rolled out?

works and burial ground maintenance, a copy of which was circulated in advance, by email with the Agenda.

The Members acknowledged that there are a lot of good works identified in the Programme and raised the following issues:-

- How will cost inflation impact the 2022 Works Programme?
- There has been no street cleaning in Thurles town on a Sunday since Covid hit in 2020.
- Has clarity been sought, following the recent Members Workshop on the Road Works Programme 2022, in relation to the road at Lismakin in order to identify the best way to move forward - 300 metres of the road had been declared a public road but a query arose in relation to the second part of the road.
- Clarity needs to be sought in relation to some roads that have been deemed to not qualify for Community Involvement Scheme (CIS) as Roads Central have subsequently stated that these roads did qualify. These roads were done previously under a CIS and now find themselves in limbo.
- When will the CCTV cameras for Thurles be upgraded and to what extent will the €70,000 allocated for Thurles CCTV under the Road Works Programme cover the project costs?
- To what extent will the €40,000 allocated under Underground Infrastructure Thurles Town go towards resolving the flooding issue at Friar Street, Thurles? Are Irish Water being consulted in relation to the works?
- Has a pedestrian crossing been included in the Ragg Junction Realignment and Safety Measures?
- Can clarity be given in relation to the street cleaning and maintenance of Market Square, Roscrea. Cleaning on Sunday mornings is also needed in this area?
- Who is responsible for road maintenance at Ballypatrick where approximately 4-5 houses are no longer on the public road following road realignment works?
- There was a commitment from the MD that, upon completion of the refurbishment works at Liberty Square, Thurles, the traffic flow for the entire town would be examined, problematic areas would be investigated and a concise plan would be put in place for the town in order to get away from the ad-hoc solution that has prevailed up to now.
- Roscrea Chamber of Commerce are seeking an urgent meeting with Thurles MD in relation to the allocation of funding towards Christmas Lighting for the town. Businesses have stated that they will no longer continue to subsidise the shortfall in funding for Christmas lighting.

#### Replies to queries raised were as follows:-

- No reply has been received to date from Roads Central in relation to the second half of the Lismakin Road. The issue will be referred to them again.
- The District Administrator will contact the Roscrea Chamber of Commerce to set up a meeting to discuss funding for Christmas lights.
- There is a plan in place to address the traffic management of the three towns of Thurles, Nenagh and Clonmel. Consultants have been appointed to carry out a Regional, Spatial and Economic Strategy to assess the existing traffic transport and movement conditions in Thurles.
- The €40,000 that has been allocated under the Road Works Programme to Underground Infrastructure Thurles Town works is not nearly enough to address the flooding issue on Friar Street, Thurles. This funding will go towards works on the N62 at Slievenamon Road, Thurles to facilitate any future storm water flood alleviation works. The funding to address the flooding at Friar Street is substantial and falls under the remit of Irish Water.
- There have been no complaints from residents/locals in relation to no Sunday morning clean up in towns.
- Tender for the appointment of Consultants for the Ragg Junction realignment and safety measures is ongoing. The inclusion of a pedestrian crossing will be examined as part of the brief.
- Roads have confirmed that the specific locations in Ballypatrick which, prior to road realignment works formed part of the public road, can still be included on a road works programme.
- Clarity will be sought and the MD will revert in relation to those roads that have been deemed to not qualify for Community Involvement Scheme (CIS) but were previously covered under this scheme.
- The plan for Thurles CCTV is to revert to the original town centre plan and examine to what extent the €70,000 allocated towards the project will allow it to advance.
- It is anticipated that cost inflation will have a significant impact on the Schedule of Works but the exact implications are not yet known. The Director of Roads is monitoring the situation carefully.
