1. To Note Adherence to Meeting Procedure Requirements

4. SICAP

Eileen Condon reported to the Committee that the midyear review of the SICAP programme had taken place on the 19th of June. The LCDC Social Inclusion subgroup met with both development companies to look at targets and budgets with regard to compliance with programme requirements. It was noted that target are based on a 5 month period.

5. <u>5.1 LEADER</u>

Michael Murray brought the members attention to a department circular detailing the reallocation to the LEADER programme nationally of €5m from the REDZ programme (Rural Economic Development Zones). The funding will be distributed between at least 10 of the top performing LAGs based on an assessment of the level of funding they have committed to projects and the level of funding actually drawn down by these projects. The decision will be based on the position of each LAG on 21st of September 2019. Based on this Michael Murray proposed that the date of the September LCDC be brought forward. The date of the 2nd of September was agreed.

She said that waste material from the production process at Medite was to be used. She added that she would revert to the promoter to seek clarification on the burner. John Lupton said that it would be desirable if the project had a higher score in the social inclusion category. Isabel Cambie responded that the project scored over 50% and that this was deemed sufficiently high. Ita Horan asked if the promoter had a contract with Medite. Isabel Cambie confirmed that a letter was on file from Medite. Cllr John Carroll (Chair) asked the members if they were happy to propose the project based on the correct licensing being in place. She said that these projects proved complicated as the Scout Hall in Clonmel is a heritage building. John Lupton asked if concerns that Minister Richard Bruton had relating to governance at Scouting Ireland were an issue. Isabel Cambie said that the Independent Evaluation Committee had discussed these issues. She added that the ETB were happy with governance at Scouting Ireland. Charles Stanley Smith said that these were great projects and a lot could be learned from them. He asked if a report could be furnished to the committee following their completion. Sean O'Farrell highlighted the need to use sustainable materials. Isabel Cambie thanked the LCDC staff of Tipperary County Council for the work they put in to get these three projects over the line.

6. Healthy Ireland

Maria Bridgeman informed the group that the Healthy Tipperary working group will meet on July 17th. They are currently working with partner agencies to identify actions that are of strategic priority for Healthy Tipperary. These would be reviewed to see which best fitted the round 3 action criteria. Dan Downey (Health Tipperary Coordinator) gave a presentation to the members on Health Ireland round 3 funding. He outlined background information on the Healthy Ireland strategy, detailed actions taken by Healthy Tipperary to date and gave a breakdown of funding available for the fourth coming two year period. Imelda Walsh said that the work undertaken to date was very impressive and that it catered for young and old. Maria Bridgeman said that the funding being available of two year period was very important. She added that €30,000 has been ring fenced for community engagement actions. John Carroll (Chair) acknowledged the input of Teresa Kiely and Fiona Crotty to the Healthy Tipperary programme.

7. Community Enhancement Programme 2019

Teresa Kiely informed the meeting that €19,634 had been allocated to Tipperary County Council under the Community Enhancement Programme for Men's and Women's Sheds. Teresa Kiely said that there are 15 Sheds in Tipperary. Teresa Kiely suggested a closing date of the 27th of August for applications given the LCDC would be meeting earlier in September. This would shorten the waiting time for applicants to draw down grants. This was accepted on the proposal of Isabel Cambie and seconded by Eileen Condon. Maria Bridgeman praised the Men's Shed movement and said that the benefits of attending one were significant. John Carroll (Chair) added that attending a Men's Sheds

-	was very empowering.
8.	Correspondence, Submissions & Consultations Teresa Kiely informed the members that two grants awarded under the Community Enhancement Programme 2019 are to be audited by the Department of Rural and Community Development. Teresa Kiely also added that and inspector from the Department of Rural and Community Development visited the LCDC team at Tipperary County Council. She examined ethics documentation in relation to the members.
	Teresa Kiely brought the meetings attention to the Tipperary Draft Climate Adaption Strategy. She told the group that the document was available for viewing on the Tipperary County Council website. She said that there was a four week period in which to make a submission. She said members could make submissions on their own behalf and the LCDC could make a submission as a whole. Teresa Kiely highlighted the areas of the Climate Adaption Strategy where the LCDC could build on. John Carroll (Chair) said that he was of the opinion that the LCDC definitely should make a submission. Charles Stanley Smith reiterated this and said it would beneficial to read other counties Climate Adaption Strategies. He said that it would be important recognize where mitigation stops and adaption begins. He emphasized the need to focus on transport. He said that electric cars weren't the answer and that there was a need for better public transport. Charles Stanley Smith pointed out that the National Planning Framework sought to cut down on unnecessary travel. Sean O'Farrell said there was a need for immediate actions to reduce carbon. Sean O'Farrell said that our foundation is nature and that there was a loss of biodiversity resulting from climate change. Sean O'Farrell said that there is a need to encourage householders to reduce food miles. John Carroll (Chair) said that submissions needed to be made before the 9 th of August. He said a meeting ought to take place shortly to collate the views of the LCDC members. Teresa Kiely sought expressions of interest for this meeting. John Carroll (Chair), Charles Stanley Smith, Sean O'Farrell and Donal Mullane expressed an interest in attending. Monday the 22 nd of July was set as the date for this meeting.
