1. To Note Adherence to Meeting Procedure Requirements

1.1 Quorum

Margo Hayes confirmed that a quorum had been achieved to proceed with the meeting. Margo welcomed Cllr Declan Burgess to his first meeting of the LCDC. She asked that Cllr Declan be nominated and ratified at today's meeting. This was done on the proposal of Isabel Cambie and seconded by Eoin Wolahan. Margo congratulated Cllr John Carroll on his re-election and he was returned as Chair of the LCDC on the proposal of Eileen Condon and seconded by John Lupton. Cllr John said he looked forward to working with the members of the LCDC.

1.2 Conflict of Interest

Margo confirmed that no notification of CoI had been received. Isabel Cambie said that the Fitzgerald's Open Farm project [STP106974] had passed the Article 48 checking process late on Friday and asked that it be brought forward to today's meeting. This was agreed.

1.3 Decision-Making Requirements to include LEADER written decision

None arising.

2. Approval of Draft Agenda

Cllr. John Carroll, Chair declared the meeting open. Apologies were noted. The draft agenda was agreed and Cllr John asked the presentation on Project Ireland 2040 Climate Action Fund be given at

this point.

2a Project Ireland 2040 Climate Action Fund

Teresa Kiely (TCC) gave a presentation on the Project Ireland 2040 Climate Action Fund after which she took questions. Cllr Joe Hannigan said that there was something wrong with process given that only 7 applications out of 97 nationally had been successful. Teresa said that the department had held a work shop with unsuccessful applicants, Cllr Joe asked what Tipperary County Council was doing to put forward indicatives in this area. Teresa said the Housing Section was involved in the retrofitting of homes to make them more energy efficient. Likewise the Roads Section had a programme to upgrade street lighting to increase its energy efficiency. She said the Tipperary Energy Agency had a 50% grant to upgrade the energy efficiency of community premises. Cllr Joe asked who in the local authority should be leading on these issues. Sean O'Farrell said that more collaboration with Tipperary Energy Agency was needed. To move forward we needed to learn from the 7 successful applicants to the fund. Our focus should be on green procurement, cutting down on carbon, rewilding and the elimination of waste. Sean added that it would be beneficial if the members could be informed of the topics of presentations in advance so as to allow them time read up on the topic.

Pat Slattery made the point that all of the council's waste water treatment facilities had been fitted with solar cells. He said that all these facilities were now linked to allow for remote management of the system and that this had been done in partnership with the Tipperary Energy Agency. He added that at any given time 10 to 12 of these types of projects are being worked on. He suggested the LCDC invite Marion O'Neill (Senior Executive Officer in the Environment and Climate Action Section Tipperary County Council) in to give a presentation. Pat said he viewed the problem as having two distinct challenges. There was need to adapt services now and to also address climate change going forward. He pointed out that the Council has a Climate Change Adaption Strategy. Sean O'Farrell asked where the council was at regarding the tertiary treatment of waste water and phosphate retrieval. Sean referenced the PPN's community wellbeing initiative as good model to use. Accountability and measurable outcomes were key.

Charles Stanley Smith supported the Tipperary Energy Agency coming in to present to the LCDC. Charles said that Minister Burton was about to make a major announcement on Climate Action. He said he expected the Tipperary Energy Agency model to be rolled out nationwide. He said that presently it was not worth recycling and that the real problem lay with manufacturers and unnecessary packaging. Eileen Condon said that we ought to try and learn from the successful applicants to the Climate Action fund. Pat Slattery said that good things were happening in this sector in Tipperary. He gave the example of the bio-refinery in Lisheen where dairy industry byproduct was being converted into a series of high-value bio-based commodities, including biodegradable plastics. A mushroom compost production plant was being developed adjacent to the bio-refinery to would use the byproduct from its

production processes. Cllr Joe Hannigan mentioned the pilot programme where by householders were being asked to demonstrate to the local authority how they were disposing of household refuse. Sean O'Farrell asked if we were going to get the Tipperary Energy Agency to come in to LCDC and could we engage with waste collectors. Pat Slattery said that our aim was still to have our workshop in September and to see what flows out of that but we had other issues to look at too. Charles Stanley Smith said that the Strategic Policy Committees had not been formed yet but he believed that one would focus entirely on climate action and the environment. Charles said that all the SPCs should present to the LCDC and Pat Slattery agreed.

3. Confirmation of Minutes

The minutes of the Tipperary LCDC meeting held on 20th of May, 2019 were agreed on the proposal of Martin Quinn and seconded by Adrian Cunneen.

Margo told the meeting that the SCIAP midyear review would take place on Wednesday the 19th of June. Margo asked for a member of the SICAP LCDC Sub-group to chair this meeting. John Lupton proposed Eileen Condon and this was seconded by Adrian Cunneen. Margo said that when the relevant documentation is up on IRIS she would circulate them to the sub-group. Pending a successful review Q3 funding would be released to the development companies. South Tipperary would get €156,263.18 and North Tipperary €122,263.18 Margo informed the meeting that an audit of the LCDC SICAP contract would follow and then finally an audit of the IPs (SICAP)

In relation to the Carmha Ireland project [30LDRntp108956] Pat Slattery asked if this could be something Jigsaw could work with when it comes to Tipperary in 2020. Eileen Condon said that Jigsaw works on a hub and spoke model and was a high profile national programme. She said that the location of the hub had yet to be decided. She said it would represent an annual investment of between €600,000 and €800,000 in Tipperary. Maria Bridgeman said that the services Jigsaw provides are quite different to that of Carmha. She pointed out that no service level agreement is in place and asked if this undermined the sustainability of the service going forward. She asked who was going to

support the payment of staff because at the moment it was not the HSE. Michael Murray said that the service was currently staffed by volunteers but that there was expertise on the board. Maria urged caution. Cllr Joe Hannigan said that mental health was a huge issue. As Chairperson of Nenagh Municipal District he wanted to support mental health services because at the moment supports were fragmented. Maria said that presently Carmha was dependant on fundraising and volunteerism. Eoin Wolohan asked if compliance was an issue and Maria responded that the model of care was not an issue. Charles Stanley Smith asked if we could insist that Carmha work with Jigsaw as a condition of approval. Martin Quinn said that we ought not to impede this project and Cllr John Carroll Chair said that there certainly was a need. Michael Murray stated that the Independent Evaluation Committee of NTDC had considered many of these issues and there was huge local support for the project. He said the philosophy of Leader was to take a risk.

5.3.3 Targeted Broadband Call

Isabel Cambie brought the meetings attention to a draft document circulated detailing a Targeted Broadband Call under LEADER 2019, for consideration by the LCDC. She said it would have a total budget of €46,924. She explained how the Development Companies had met Simon Howe (County Broadband Officer) to discuss the call in the context of the announcement of the National Broadband Plan. She told the meeting that the minimum grant would be €5,000 and the maximum would be €10,000. Isabel Cambie outlined a proposed timeline:

24/06/2019 Advertisement of Call – Local press, social media

24/07/2019 Expressions of Interest (EOI) received

02/08/2019 EOIs assessed and eligible promoters invited to submit full application.

25/09/2019 Full applications received – all must have procurement and planning completed.

18/11/2019 Projects presented to LCDC

Pat Slattery asked if Broadband Connection Point locations could apply. Michael Murray confirmed that they could. Cllr Joe Hannigan asked if this could be used to develop remote working facilities. Michael Murray confirmed that remote working locations were covered under the call. The call was approved on the proposal of Eileen Condon and seconded by Martin Quinn.

6. **Healthy Ireland**

Maria Bridgman informed the meeting that Health Ireland funding of €107,000 had been allocated for 2019 and €77,000 for 2020. She said that at this point it was not clear if this was inclusive of the €30,000 for formal membership of the Health Cities and Counties initiative. She added that the process templates for funding had not yet been set. CYPSC have been allocated €96,000 over two years. Maria Bridgeman said that applications will be reviewed and a proposal will brought before the LCDC. Teresa Kiely suggested that a joint LCDC/CYPSC application be undertaken again this year. Maria highlighted 5k/10k run at Nenagh Eire Óg on the 23rd of June that HSE Health and Wellbeing Section were partnering with to promote a wellbeing event.

7. Community Enhancement Programme 2019

Teresa Kiely lead this item. A document was circulated to the members detailing applications received and proposed funding allocations under the Community Enhancement Programme 2019. Teresa told the group that €149,690 of funding had been allocated from the Department of Community and Rural Development for the programme this year. Applications totaling €480,213.26 had been received. One third of total funding had to be allocated to applications of less than €1,000. Teresa explained how the Pobal Deprivation Index was used to determine successful applicants, and the percentage of overall funding these applications received. Cllr Declan Burgess asked how the successful Youth Work Ireland Tipperary project was selected given that Youth

Work Ireland Tipperary had made a number of applications. Teresa replied that she spoke to the Chief Executive of Youth Work Ireland Tipperary and she had prioritised the successful application. Donal Mullane asked why some applications, that had been considered, had received 0% funding. Teresa said this was because those areas had either an above average or an affluent score on the deprivation index. In some cases sheds received less as a scheme for them is forthcoming. The recommendations were approved on the proposal of Imelda Walsh and seconded by Eileen Condon.

8. <u>Correspondence, Submissions & Consultations</u>

Margo Hayes told the group that the PPN had held its Community Wellbeing Consultation in Kilfeackle on the 29th of May and that it had been very successful. Charles Stanley Smith said that 50 people had attended. He said the feedback gathered on the night was available on the PPN website and the plan was to have similar consultations in the other municipal districts.

Margo Hayes informed the meeting that the Age Friendly Older Persons Council consultations had begun. Meetings had been held in Clonmel, Nenagh and Carrick-on-Suir. Meetings in Thurles and Tipperary Town would take place shortly.

Margo Hayes brought the meeting's attention to a letter the LCDC had received from the Minister of State for the Diaspora and International Development, Mr. Ciarán Cannon T.D. The Minister was inviting submissions to inform the development of Ireland's new diaspora policy. Cllr. John Carroll, Chair, said that this would be something the LCDC would very much like do.

Margo Hayes gave details on the LECP biannual review which is to take place on June 20^{th} .

Sean O'Farrell asked about the timeframe for making submissions to the Tipperary County Council Climate Change Adaptation Strategy. Teresa Kiely said that had not been advertised yet.

Eileen Condon mentioned that the ETB brochure had been posted out to every household in the county.

9. <u>AOB</u>

Margo Hayes told the members that some of them had been provided with ethics documentation relating to their membership of the LCDC. These needed to be filled out and returned. Cllr. John Carroll, Chair, extended the LCDC's sympathies to John Lupton on the recent passing of his brother-in-law.

10. Next Meeting
