New Leader Programme

The CAP budget was agreed on 31st August and this should now in turn commence the new Leader Programme rollout. Michael Murray stated that it is anticipated that correspondence will issue shortly from the Department re the

new LEADER Programme. As the Local Action Group (LAG) the first step will be to submit an Expressions of Interest will come before the LCDC as the LAG. If the LCDC is successful as the LAG then the LAG will have to have a new Local Development Strategy in place by 31st August 2023. Margo added that it is an exciting opportunity to direct on where to prioritise if you identify gaps and it is important to engage and have your say as LCDC.

IEC membership

Isabel raised the issue of vacancies for South Tipperary Development Company Independent Evaluation Committee as four people have left. Quorum will be difficult to reach in the current situation which may result in a delay in project processing.

Approval was sought that for the remainder of the LEADER Programme (to December 2022) -NTDC and STDC can nominate members to the IECs through the co-option process. Regard must be made to the ethics documents to include Code of Conduct and Conflict of Interest Documentation etc. This was agreed on the proposal of Gearoid O'Foighil seconded by Derry O'Donnell.

Fiona Crotty advised that the governance of Healthy Ireland was a function of the LCDC and approval and recommendations in relation to Healthy Ireland would be brought to the LCDC. This recommendation was approved by Mike Edwards and seconded by Cllr John Carroll.

Healthy Ireland Strand 4 Strategy

Fiona Crotty advised that the Department of Health are holding a briefing session for the Chief Officers and Healthy Ireland Coordinator on 5th October to provide information in relation to the overarching Healthy Ireland round 4 framework and our requirement to complete a local strategy for Healthy Ireland Funding 2023-2025 and an activities workplan for 2023 by 9th December. Further information will be provided to the LCDC following the 5th October briefing.

Age Friendly

Fiona Crotty advised on events and activities in County Tipperary to celebrate Positive Ageing Week 26th to 30th September. The LCDC had previously approved ringfenced CAF funding for Age Friendly and this was supporting the local groups hosting events in the county.

Fiona also advised about ongoing work in relation to Healthy Ireland which had been a previous LCDC Healthy Ireland action. September is National Brain Health month and world Alzheimer's Day is 21st September. Tipperary Town library will host a craft group working on a fidget blanket project to mark this date and Tipperary County Council, Silver Arch FRC and Ballingarry Community Development are working on a signposting website for county Tipperary on dementia www.demenitatipperary.ie

Sláintecare Healthy Communities Clonmel

Stephanie O'Callaghan updated the Committee on promotion of Healthy Communities in Clonmel. She is working with community group from the Old Bridge, as a pilot/focus group community, at present addressing what they want and how they want it to move forward. Stephanie outlined the community development work undertaken to date and building the profile of Healthy Communities in Clonmel. She is working with Children and Young Peoples Services for the Town of Clonmel and how to engage children in consultation and will work with South Tipperary Arts Centre to deliver on same. She is also working with parents, services and agencies in relation to developing social activity opportunities for children and young people with disabilities in the community. Fiona outlined again for the new members that the Governance of the Healthy Communities Programme is with the LCDC therefore reporting on the actions of this project will come before the LCDC.

Period & Hygiene Poverty

Collectively Stephanie, Fiona and Aine are working on hygiene security, this action received specific funding from Department of health and additional funding has been provided by Healthy Ireland, Healthy Communities to deliver on same.

Make Way Day

Aine Roche also advised that 30th September is 'Make Way Day' and asked if you have any photos they can hashtag '#Make Way Day 22' and be part of the overall campaign.

ISL - Irish Sign Language Week 19th to 25th September

ISL – Irish Sign Language Week is this week. ISL is officially the 3rd recognized language in Ireland. Tipperary County Council have been partners on building awareness of and use of ISL over the last few years.

The tag line of our campaign is "Give it a go and help it grow". Tipperary Library service have now complied over 40 stories aimed at the young audience incorporating ISL and on Saturday 17th in Clonmel Library we had a live story time featuring ISL. Under previous funding we had prepared instructional recordings, which are now been revised with full ISL and then with the support of the Healthy Ireland Funding this will be developed into a training portal for use across all sectors.

7. Update on LECP Development

Margo updated on the LECP stating an Advisory Group has been set up and has identified high level goals. Agency consultations on the goals through SPC's has taken place and there were number of submissions. Three tenders for the Socio

Economic Profile have come is. Community Consultation through will be through the PPN.

8. Correspondence, Submissions & Consultations

Margoinformed the Committee Children and Young Peoples Service Committee (CYPSC) are launching their Strategic Plan 2022-2025 plan in Thurles 3pm on 11th October.

She stated an invitation for Public Consultation from the Department of Social Protection for the Roadmap for Social Inclusion Mid-Term Review launched on 6th September - details will be circulated to LCDC.

PPN Review Submission

At the July meeting Fiona advised that the Department had carried out a structural review of the PPN and sought feedback from each LCDC on same. Following an invitation to participate in the feedback a sub group of the LCDC meet on 24th August. Representing and participating from the LCDC, Cllr John Carroll, EoinWolohan and Julie O'Halloran joined by Ruth Smith from Tipperary PPN. We prepared a submission based on the report, this submission has been circulated to all members. Ultimately the integrity and independence of the PPN, how the PPN can be strengthened and embedded underpinned our feedback and Option 2 in terms of implementation as a compromise. Fiona acknowledged the participation of all of the sub group and we further recommended that the department provide for creation of community statements based on well being visions which can be used for involving communities at local level.
