She stated 700 Hygiene Security Packs were distributed to community groups in January.

Training for Inclusive Universal Design will take place in conjunction with Anne Bradshaw Goldstar and Cancer Care.

The Quality of Life Structure will be replicating the Iceland Model leading out a Substance Misuse Programme in Clonmel.
