1.2 Election of Cathaoirleach

Council and to the newly elected Members stating that Thurles MD Members have a very workable and strong partnership.

The Cathaoirleach acknowledged the recent funding received by Tipperary County Council under the EU Just Transition Regenerative Tourism and Placemaking Scheme towards the regeneration of Castle Street, Roscrea and the further development of the Bord na Mona trail at Littleton. He stated that he wanted his year as Cathaoirleach to be a year of integration, not segregation, to look at the great work being done in communities and to welcome all into our towns.

The Cathaoirleach stated that the refurbished Templemore Town Hall will be re-opened before the end of the year and he believes that there is an opening in the town hall for a tourism hub. He stated that the Council and the local community will work together to create a community space.

1.3 Election of Leas-Cathaoirleach
