

1. GENERAL

On 21.10.2024 a request was made for a declaration under Section 5 of the Planning and Development Act, 2000 as amended as to whether or not the following works constituted development and if so, whether same was exempted development:

Change of use from residential to commercial use as tattoo parlour/beauty salon.

No physical alterations are required to the building layout and the proposal relates to a change of use only.

2. STATUTORY PROVISIONS

The following statutory provisions are relevant to this referral case;

Planning and Development Act 2000, as amended:

Section 3 (1) of the Planning and Development Act 2000, as amended, states as follows:-

"In this Act, 'development' means, except where the context otherwise requires, the carrying out of works on, in, over or under land or the making of <u>any</u> material change in the use of any structures or other land."

Section 2(1) of the Planning and Development Act, 2000, as amended, defines "works" as:-

"works" includes any act or operation of construction, excavation, demolition, extension, alteration, repair or renewal and, in relation to a protected structure or proposed protected structure, includes any act or operation involving the application or removal of plaster, paint, wallpaper, tiles or other material to or from the surfaces of the interior or exterior of a structure.

Planning and Development Regulations 2001, as amended:

Article 6 of the Planning and Development Regulations 2001, as amended states:

Exempted Development.

6. (1) Subject to article 9, development of a class specified in column 1 of Part 1 of Schedule 2 shall be exempted development for the purposes of the Act, provided that such development complies with the conditions and limitations specified in column 2 of the said Part 1 opposite the mention of that class in the said column 1.

Schedule 2, Part 1 'Exempted Development - General:

Class 14 of Part 1 of Schedule 2 of the Planning and Development Regulations 2001, as amended sets out planning exemptions of changes of use. There is no exemption under this Class for the change of use of a residence to a commercial unit.

Article 10 of the Planning and Development Regulations 2001, as amended provides an exemption for development which consists of a change of <u>use within any one of the</u> <u>classes of use specified in Part 4 of Schedule 2</u>, provided that the development if carried out would not

(a) involve the carrying out of any works other

than works which are exempted development,

(b) contravene a condition attached to a permission under the Act,

(c) be inconsistent with any use specified or included in such a permission, or

(d) be a development where the existing use is an unauthorised use, save where such change of use consists of the resumption of a use which is not unauthorised and which has not been abandoned

3. ASSESSMENT

a. Site Location

The site is located at 2 Liberty Square, Thurles, Co. Tipperary

b. Relevant Planning History

84540971 – Planning permission granted for change of ground floor to opticians

c. Assessment

A) <u>"Is or is not Development"</u>

It is considered that the above listed proposal constitutes "development" within the meaning of the Planning and Development Act 2000, as amended as it would result in a material change of use of the premises from residential use to commercial use (use as a tattoo parlour/beauty salon).

B) <u>"Is or is not Exempted Development"</u>

I note no exemptions under the Planning and Development Regulations 2001, as amended or the Planning and Development Act 2000, as amended that apply to the proposal.

C) <u>Restrictions under Article 9</u>

N/a as no exemption under Article 6 confirmed.

d. Requirement for Appropriate Assessment (AA) and Environmental Impact Assessment (EIA)
