

An allocation of €5m has been approved for Tipperary County Council under this Call and €1m of this allocation has been paid in advance to assist with early activity under an approved acquisition programme in the URDF designated towns of Clonmel, Nenagh and Thurles.

Carrick on Suir Local Area Plan 2025-2031

A Draft Plan was published on Friday, 25th October 2024, with public consultation then ongoing until Monday, 9th December 2024. A public drop-in event was held in Carrick-on-Suir Library on 13th November 2024, where members of the general public engaged with the Planning Policy team questions about the Plan. 23 submissions were received on the Draft LAP and a Chief Executive's (CE) Report will be shared in early January 2025 with Elected Members.

The CE report outlines the submissions received, provides a summary of each of submission, and the CE's consideration and recommendation on each submission. A workshop will be provided in January 2025 for members of the Carrick-on Suir MD to outline the recommendations contained within the CE report, the implications of these recommendations, next steps and the decisions required.

At the plenary meeting in February 2025, a decision will be required to: (i) <u>make</u> the Carrick-on-Suir Local Area Plan 2025-2031; (ii) <u>amend</u> the Draft Carrick-on-Suir Local Area Plan 2025-2031 in accordance with the CE recommendations <u>OR</u> (iii) <u>amend</u> the Draft Carrick-on-Suir Local Area Plan 2025-2031 in accordance with some / all of the CE recommendations and other changes.



Residential Zoned Land Tax

The Residential Zoned Land Tax (RZLT) is reviewed and updated annually. Public Consultation on the RZLT 2025 opened on 1st February 2024 with the publication of Draft Maps. People had an opportunity to make submissions on whether lands should be included / excluded on the Final Maps until 1st April, and until 31st May to make submissions on requests to amend the land use zoning of lands.

13 Submissions were received on whether lands should be included / excluded on the Final Maps. 9 of these submissions were from landowners, and specific "Determinations" where required on these 9 submissions. Three appeals were received by An Bord Pleanála on the Determinations made by TCC and the decision of TCC were upheld in each of these cases.

The Planning section has been surveying settlements that are subject to the RZLT in preparation for the publication of Final Maps for the RZLT 2025 and the Draft Maps for the RZLT 2026. The final Maps for RZLT 2025 will be published on 31st January 2025.

Draft Maps for the RZLT 2026, with an opportunity to make submissions, will be published on 1st February 2025. Consultation will be open until 1st April 2025.

First Revision to the National Planning Framework

Government published the First Revision to the National Planning Framework (NPF) on 10th July 2024 for consultation with a closing date for submissions of 12th September 2024. The Planning Section led on the drafting of a submission, engaging with each directorate in the Council for comments and input.

Tipperary County Council made a detailed submission focusing on 4 key themes: 1) balanced regional development; 2) Tipperary's place in the region; 3) investing in infrastructure and; 4) A Just Transition and the BioEconomy, as well as other critical areas. The submission included 17 recommendations for Government to consider. The government received 272 submissions in total.

On 5th November, Cabinet agreed the changes the First Revision to the NPF following publication. The changes are subject to environmental assessment, which will be carried out in the coming weeks and months. Once this process is complete, the final draft will then be submitted to the Houses of the Oireachtas for their approval. This is likely to occur in Q1 or Q2 2025.

Conservation Grant Schemes 2024 and 2025

Applications are now being accepted for the Historic Structures Fund 2025 and BHIS Historic Thatch Buildings Grant 2025 – Closing date 17th January, 2025 4 pm strictly.

<u>Historic Structures Fund 2025 - Closing 17/01/2025 4pm</u>

The Historic Structures Fund will invest essential capital in our valuable built heritage and help the owners and custodians of historic structures to safeguard them into the future for the benefit of communities and the public. The Historic Structures Fund will offer grants from €50,000 up to



€200,000 only, and focus on larger enhancement, refurbishment or reuse projects involving heritage structures, where:

A clear community or public benefit has been demonstrated, or a clear residential benefit has been demonstrated (such projects must be advanced through the planning process as necessary)

BHIS Historic Thatch Buildings Stream 2025 - Closing 17/01/2025 4pm

The purpose of the scheme is to protect the heritage value of historic thatched roof buildings across Ireland, including dwellings and other structures. For 2025, the Historic Thatched Buildings Grant will offer funding offers of up to €20,000. Any historic thatched structure built before 1970, including domestic or commercial properties, is eligible to apply for grant funding under this scheme.

Built Heritage Investment Scheme 2025 – Scheme Now Closed

The Department of Housing, Local Government and Heritage, has announced the continued implementation of the Built Heritage Investment Scheme (BHIS) 2025, which includes revised timeframes and criteria to incorporate elements of Historic Structures Fund (HSF) Stream 1.

Applications were invited under the scheme for 2025 works. Grants of up to €50,000 are available to cover the cost of repair and conservation of protected structures. The closing date for submission of completed applications was **4.00pm on Friday 27**th **September, 2024**. Tipperary County Council received 40 applications under the scheme and have made a recommendation to the Department of Housing, Local Government and Heritage for 33 projects to receive funding under the scheme. A decision on same is expected late-January 2025 and applicants will then be notified of the outcome of their application.





<u>Community Monuments Fund 2025</u> <u>launched</u>

The Community Monuments Fund (CMF) aims to assist with conservation, research and interpretation of archaeological monuments by communities and private owners. The scheme is funded by the National Monuments Service of the Department of Housing, Local Government. Grants will help custodians and owners of archaeological monuments to safeguard them into the future for the benefit of local communities and the visiting public. In addition, they will provide support for heritage professions and job opportunities in building conservation and other traditional skills. The core aims of the Community Monuments Fund are the conservation, maintenance,



protection and presentation of archaeological monuments.

Funding is available for:

- Conservation works to monuments which are deemed to be significant and in need of urgent support.
- Works to improve access to and presentation of monuments.
- Building resilience into monuments to enable them to withstand the effects of climate change.
- Funding for 2025 is now open for applications and is available in three streams

Stream 1 offer grants up to €100,00 for essential repairs and conservation works for the conservation of archaeological monuments.

Stream 2 offer grants up to €30,000 for development of Conservation Management Plans/Reports and detailed specification of works aimed at identifying measures for conservation of archaeological monuments and improving public access.

Stream 3 offer grants up to €30,000 for enhancement of access infrastructure and interpretation projects (including virtual/online) and small-scale emergency conservation works at archaeological monuments.





COMMERCIAL RATES

As at 30/11/2024 Rate Accruals for 2024 amounted to €36,242,540.

Arrears of €5,520,979 were brought forward from 2023, giving the total amount to be collected as €41,763,519. Reductions of €1,114,542, have been applied to individual accounts following ReValuation Appeals finalised in 2024. This amount was in relation to the financial years 2020-2023. Write offs in the amount of €801,592 have been processed to date in 2024.

Receipts of $\$ 33,167,468, (83%), were recorded to 30/11/2024.

INCREASED COST OF BUSINESS GRANT

ICOB #1 Grants in the amount of €4,454,448 have been paid out to 2,999 customers to date.

ICOB #2 Grants in the amount of €2,904,404 have been processed for 1,891 customers.

The grant was available to qualifying businesses as a contribution towards the rising costs faced by businesses. The grant was intended to aid businesses but not intended to directly compensate for all increases in wages, or other costs, for every business.

POWER UP GRANT

This grant was available to businesses in the Hospitality, Retail and Beauty Sectors who received the ICOB 2 Grant. 1,566 submissions have been received. 1,344 grants were paid in November, in the amount of €6,248,000.

RATES PAYMENT INCENTIVE SCHEME 2024

Approximately 4,150 (90%) of customers are eligible to benefit from our Rates Payment Incentive Scheme in 2024. If fully subscribed and availed of this could achieve total reductions in their rates of €648,249.

The terms for our Rates Payment Incentive Scheme for 2024 are: -

- Applied to all ratepayers with an annual rates bill of up to €26,000.
- To avail of the Early Payment Reduction of 6%, subject to a maximum of €600, payment of rates must be made in full, by 31st July 2024.
- Customers paying by Direct Debit can avail of the scheme if payment is made by September 2024.



The scheme is open to customers with arrears on their accounts where they pay a minimum amount which is equivalent to the annual rates by the same timelines outlined above, and enter into a structured payment plan to address and eliminate arrears.

Credits under the RPIS will be applied to the bulk of qualifying customers in September.

2,013 Customers have benefitted from the RPIS to date in 2024, in the amount of €342,433.

VACANT PROPERTY RELIEF

Commercial Rates remain payable on vacant property. Where a property is vacant on the date of making the rate, owners must notify the local authority and advise that the property is vacant and for letting, or is closed for refurbishment or repair.

Vacancy relief will be applied to qualifying property in accordance with the following scale:
