### **5.1 Cllr. John O'Heney (Ref. ID 2965)**

That this Council would upgrade or replace the broken fence starting from the Bridge in Bansha Village, that

continues on the L4306, towards the Railway Line. This fence is in considerable need of maintenance and is an eye sore as you enter the Village.

## 5.2 Cllr. John O'Heney (Ref. ID 2966)

At the request of the Cullen Tidy Towns Association, that this Council would install a Water Tap on the grounds of Cullen Graveyard.

## 5.3 Cllr. Liam Browne (Ref. ID 2970)

That the footpath extending from New Inn village, adjacent to the R639 towards Cashel, on the left hand side of the road, be extended from it's current position, up to the 100kph speed limit sign.

## 5.4 Cllr. Liam Browne (Ref. ID 2971)

That a delegation from this Municipal District area, immediately seek a meeting with the Minister Norma Foley, Minister at the Department of for Children, Disability and Equality, to discuss the awarding of a two year contract for the accommodation of International Protection Applicants on a temporary basis, at Dundrum House, Co. Tipperary.

This meeting should be done with a view to creating a task force across a range of national and local public services (eg extra educational/training needs, extra sporting leisure facilities etc) to ensure the needs of both the current local population in the area, and any extra people moved into the area, will be adequately met in the short and long term.

That this Municipal District appoint a delegation to meet Minister for Justice Jim O Callaghan T.D. to discuss the possible benefits to the Community of Dundrum after the expiry of the IPAS contract.

That this District upgrade the footpaths in St. John's Famine Graveyard. The St. John's Famine Graveyard Voluntary Committee have spent many years looking after the famine graveyard and now need assistance from the Local Authority to renovate the footpaths. Furthermore, that this Local Authority take in charge the famine graveyard as it is currently without official ownership since the dissolution of the former Board of Guardians. (The committee would like it noted that they appreciate the recent efforts by Tipperary County Council to ascertain ownership status of the Graveyard)?.
