2. Election of LCDC Chairperson

Mike advised the members that he was seeking nominees for the position of a new LCDC Chairperson.

Cllr. Marie Murphy nominated Cllr. John Carroll for the position and Cllr. Anne Marie Ryan (Shiner) seconded his nomination. As there were no other nominations, Cllr. John Carroll was elected. He thanked the members and then took the Chair.

Mike Edwards thanked Eoin Wolahan for all his hard work as chairperson of the LCDC, said he would be sorely missed and wished him good luck for the future. Brian Beck also acknowledged Eoin's work and dedication to the LCDC and asked that a letter of thanks be sent to Eoin on behalf of all the members of the LCDC and that he be invited to Christmas Lunch as a small thank you.

Cllr. John Carroll thanked Eoin for being a wonderful Chairperson, he said he had a great command of the brief and he wished him well for the future. He then welcomed Elaine Baker introducing her as the new PPN nominee on the LCDC replacing Gearoid O Foighil.

The minutes of the Tipperary LCDC meeting held on the 16th September, 2024 LCDC Meeting were agreed on the proposal of Cllr. Marie Murphy and seconded by Mike Edwards.

5. SICAP

Michael Murray gave a presentation on the SICAP NTDC Q4 Report. He advised that the NTDC had two Goals

Goal One: Contribute to Building more sustainable, inclusive and empowered communities

NTDC engaged in Local Development Week which took place from Monday 23rd of September – Friday 27th of September. NTDC showcased events that were taking place this week such as a Training Workshop on Digital Marketing for new businesses in the NTDC premises on Kickham Street in Thurles. The SICAP Community Development Worker in Roscrea/Nenagh has engaged with existing and established new resident's groups in both towns this quarter. NTDC SICAP now have an additional 7 registered Resident's Groups in North Tipperary. The SICAP team supported numerous community groups over this period with funding and support for summer trips, social pop ups and integration events.

Goal Two: Empower people experiencing disadvantage to improve their quality of life

The Development Officers continue their work across this goal with current and new individual beneficiaries. This work is spread across all the actions in goal two.

NTDC received additional funding under the International Protection Integration Fund with the proposal to deliver training programmes, language supports and summer camp places to children living in Direct provision and IPAS centres. A collaboration is underway with NTDC/Traveller Health Programme to provide a group of Traveller men with the opportunity to attend courses related to their interests an example of this would be 'Horse Welfare' course. The SICAP Community Development Worker is also working on 'breaking down barriers' with the group with things like education, employment and integration into the community.

SICAP have been collaborating with the TUS/CE scheme to identify employment opportunities for people living in IPAS Centres across North Tipperary.

SICAP hosted food safety level 1 &2 this quarter, along with manual handling courses and safe pass courses in line with pathways to employment. SICAP are currently doing a collaboration with Roscrea Youth Service to work with a group of young men aged 16-24 with employment and education. A first aid course, along with a safe pass course, mentoring 1-1, CV workshop and interview skills is underway.

SICAP hosted food safety level 1 &2 this quarter, along with manual handling courses and safe pass courses in line with pathways to employment. SICAP are currently doing a collaboration with Roscrea Youth Service to work with a group of young men aged 16-24 with employment and education. A first aid course, along with a safe pass course, mentoring 1-1, CV workshop and interview skills is underway.

2.1 Bringing Learning to Life

Men's Sheds from Roscrea, Thurles and Moycarky/Borris/Littleton pictured in Dromineer before embarking for their biodiversity study tour on Lough Derg. The trip took them around Bushy Island (off Mountshannon, Co. Clare) to view the white-tailed sea eagles, then through the wetlands to Tuamgraney, before returning to Garrykennedy for lunch. The tour was the culmination of a Biodiversity and Water Quality program delivered in the Sheds over the summer.

The program was funded by Tipperary ETB (REACH) and delivered by North Tipperary Development Company through the SICAP Programme. Additional sponsorship for the boat trip was provided by Ku-ee-tu Cruises Dromineer, Larkins Restaurant Garrykennedy, and Finnertys Pharmacy Nenagh which sponsored the suncream.

Isabel Cambie gave a presentation on the SICAP STDC Q4 Report. She advised that the STDC had two Goals

Goal 1 Animating Local Communities to address their collective needs LGBTQI+ Health and Wellbeing Event

In 2023 SICAP received a small grant of €900 through the Dormant Accounts Fund to provide supports to the LGBTQI+ community. The SICAP Development Officer who has the remit for work involving the LGBTQI+ community had already commenced making links with the community and identifying the needs of the community

Goal 2 Healthy Food Made Easy

A 6-week HFME course was held in KRC in Tipperary Town. This course is designed to provide valuable skills and knowledge to participants. 11 participants progressed to completion of HAACP. A new youth work group specifically for Ukrainian children was launched in September in Cahir with the support of YWI. This initiative aims to support integration and provide a welcoming environment for young newcomers.

Disadvantaged Children & Families

The Family Literacy Project was launched in Tipperary Town in 2023 with the aim of improving literacy skills and creating a supportive learning environment for Traveller families, including children, parents, grandparents, and carers. It was delivered by SICAP staff in Knockanrawley Resource Centre in collaboration with STDC and focused on addressing the educational and social inclusion needs of the Traveller community. The initiative was funded in partnership with SICAP, SOLAS and CYPSC and attracted significant participation from local families. In 2024, the programme expanded to include literacy skills related to cooking and nutrition in partnership with the Education and Training Board (ETB), further supporting family learning.

Cllr. Annemarie Ryan(Shiner) thanked Michael and Isabel for their presentations. Sinead Carr also thanked Michael and Isabel for a job well done and stressed that Intergration was essential.

Michael Murray then shared a reel with the SICAP highlights.

Cllr. John Carroll asked if there was much progress in the finding accommodation for Mens Sheds? Michael said there was a study being done on same and he would bring the results to the LCDC when completed.

Elaine Baker said there was great work being carried out and asked if there was any way of ensuring that local food could be introduced to the projects.

Cora Morrissey then gave a report on the Financial review of SICAP.

Michael Murray requested that €14,000 from the projected salary underspend in 2024 be allocated to the following Goal action budget

1.1 Empowering Communities	€5,000
1.2 Collective Action	€5,000
2.6 Human Rights	€4,000

This was agreed on the proposal of Mike Edwards and seconded by Elaine Cullinane.

Cora Morrissey advised the members that as part of the SICAP 2025 annual planning process, we are asked to review your 2024 targets in preparation for the 2025 SICAP Annual Plans. If we are making changes to the targets we must have the templates back to Pobal by November 1st 2024. The LCDC sets annual KPI targets based on an indicative level established by the Department each year. The indicative target can be increased or decreased by a maximum of 15% by the LCDC.

Cora has linked with the development companies and they are confident that in 2025 they can meet increased targets of 8% for community groups (KPI 1) and 1% for individual beneficiaries (KPI 2) as shown below.

Munster Vales CLG (Motorcycle Tourism Feasibility Study)

The concept is to turn the Munster Vales into a motorcycle touring hub, where the pace of touring is slower, cultural immersion is possible, and it can be used as a base for visiting some of the spectacular sites and motorcycling roads within and adjacent to the region. Using various research methods, including surveys, interviews, site visits, and data analysis, to assess the feasibility of motorcycle tourism, the study will highlight partnerships and collaborations with local motorcycle clubs, tourism organizations, and volunteer groups.

South Tipperary Development CLG (SMART Sustainable Village Training)

South Tipperary Development CLG wishes to offer a bespoke training programme to support 5 South Tipperary communities to develop SMART Sustainable Village Plans (at least one per Municipal District). The SMART Village programme is designated by the EU and recommended as a framework for village planning under LEADER. According to the EU "SMART Villages are communities in rural areas that use innovative solutions to improve their resilience, building on local strengths and opportunities. They rely on a participatory approach to develop and implement their strategy to improve their economic, social, environmental, and cultural conditions, including mobilising solutions offered by digital technologies. The SMART Villages concept brings a fresh approach and opens new opportunities to improve the sustainability and resilience of rural areas and communities, delivering on the promise of "a better life in Rural Areas and reflects the principle and methods associated with SMART areas." In our case, the programme will integrate best practice in SMART Village planning and Environmental / Sustainability issues. At least one programme will be delivered in a disadvantaged urban community within a larger town. (Note, within an EU context, all of South Tipperary is classified as rural, and the term Village covers the majority of settlements)

Michael Murrary submitted a proposal for IEC committee consideration Questions have been raised concerning scoring of applicant projects under assessment headings related to climate and biodiversity implications. Relevancy is attributable to the/any project exploration and application stages as it concerns existing national policies around climate and nature and a greater clarity need for evaluation committee members to carry out their role. The proposal is to request Tipperary LCDC committee with support from Tipperary County Council's Environment Section to design a useful and practical checklist that applicant groups and organisations can complete that will demonstrate effort taken with project materials procurement, usage and installation that have regard to sustainable LA climate and nature actions.

It was agreed that a Sustainable Communities' Sub Group would be called to discuss this proposal

As there are new members to the LCDC it was agreed to circulate the current Sub Committees of the LCDC and seek nominations to same for the next LCDC meeting

7 Quality of Life

7.1 Healthy Ireland Fund (HIF) 2023-2025 update

Fiona Crotty gave an update on the Healthy Ireland Fund. Examples of some of the programmes been delivered through the Healthy Ireland funding in the Littleton area delivered by North Tipperary Development Company and the health indicator been funded is to increase the social activity levels of people aged over 50+, and to increase physical activity levels of children and adults.

Mental Health Week

Tipperary Mental Health week took place from 7th October to 13th October 2024.

The official launch was 27th September in TUS College Campus in Thurles. The main event that took place for the week was a talk by former governor of Mount Joy John Lonergan on 9th October in TUS Thurles Campus about mental health, family and community.

Healthy Tipperary and Tipperary PPN Health and Wellbeing Shows Healthy Tipperary and Tipperary PPN have partnered to host health and Well Being wellbeing Roadshows across the Municipal Districts this Autumn. The roadshows include information stands and health checks and it is an opportunity for members of the community to engage with different agencies and input into the review of the Tipperary PPN Wellbeing Vision. The next roadshow is on in Clonmel in Hillview on 5th November and 19th November in Fethard Town Park.

Make Way Day

Make Way day took place Nationally on 27th September this was a national campaign to highlight the miss use of Disabled parking spaces and to highlight what obstacles block people with disabilities o their everyday tasks. Healthy Tipperary partnered up with Tipp Town Branch of The Irish wheelchair association and Carrick MD to do a walkability in the town of Carrick On Suir. Present at the walkability was local Cllr David Dunne, District administrator Marie Cox, Senior executive Engineer Denis Power, Marie Dunne Traffic Warden.

This Walkability highlighted the difficulties faced by people with disabilities when people park in disabled spaces with out a permit or parking incorrectly and block a disabled parking space, what was also highlighted was the footpaths and paving near the spaces were not accessible in some areas and this was noted by the staff in Carrick Md and changes will be made and issues highlighted from the walkability will be acted on.

The Launch of the 5 Ways Well Being Boards

The boards were officially launched as part of the planet youth launch in Tus Thurles Campus om 23rd September present was Minister Mary Butler, Tipperary GAA reps, Mental health Ireland Development workers, HSE and local Clirs



7.2 Sláintecare Healthy Communities Clonmel

Substance Misuse Action Plan

Dr Marie Walsh TUS Clonmel met with the four cohort chairpersons (Businesses & Hospitality, Clubs & Groups, Lived Experience and Parents & Schools) on the 4th October and also presented further mapping of Community Conversation data to the Substance Use alliance on the 18th October. The four cohort's chairpersons will convene subgroup meetings with the view to holding a public meeting in Quarter 1 2025.

Marie will present Community Conversation findings at this public meeting (focusing on what was heard at the different Community Conversations) The session will lay out:

- the key priorities identified by the Community and there will be an opportunity for those present to ask questions and discuss the findings.
- feed back the commitments of the agencies/ service providers in response to what they heard from the community. Some of these initiatives/ actions may need community input.
- focus on discussions in cohort groupings about how community members themselves can take action and the supports they need.

Drugs Rehabilitation CE Scheme

STDC plan to submit an application to the DSP Monitoring committee in January 2025.





The 1st ever health and well-being festival took place at the Technological University of the Shannon (TUS) Clonmel campus on Thursday Sept 26th. Over 500 people took part in this event where participants were encouraged to get arty and crafty with local artists. Patrick Davoren - manager of the Regional Sports Hub said that "organisers wanted to increase community awareness of the TUS University/Sports Hub and highlight the importance of social inclusion". Several local schools attended on the day and Patrick is delighted that more and more people are coming to use the Sports Hub/track/playground.

In 2023, the Consultation with Children and Young People asked 182 young people in Clonmel about the kind of community they wanted to create. They highlighted the need to have events for young people organised by young people. Slaintecare Healthy Communities programme responded by kindly providing the funding for this festival day. This event was organised by a

dedicated group of students from TUS and well supported by the Student Union. Marie Walsh, one of the TUS Lecturers commended the creativity of the group of student volunteers who brought their vision to life. This was reinforced by Catriona Crowe from Slaintecare Healthy Communities Programme, with Tipperary County Council who was present on the day and highlighted the importance of youth led projects

Place Standard Tool Training - Old Bridge Clonmel

Place Standard took place in Old Bridge on the 2nd October 2024. We used what is called the "PLACE STANDARD TOOL" which seeks to get Old Bridge community's views and opinions on how good Old Bridge is as a place to live by completing a survey.

The results of the survey highlighted identity and belonging, influence & sense of control, housing & community, social interactions, natural spaces needing little room for improvement and Moving around, public transport, traffic & parking, play & recreation needing lots of improvement. The next steps are: Feedback report to the Old Bridge community and agencies. Roll out Place Standard with young people and older adults in the Old Bridge area

Tusla's Child and Youth Participation Award

Tipperary County Council achieved the Child and Youth Participation Award for their Quality-of-life consultation with the children and young people of Clonmel. To carry out the consultation Tipperary County Council sought to collaborate with TUS and the South Tipperary Arts Centre. The consultations took the form of focus groups with varying age cohorts from a range of schools, education centres and a third level institute. The awards ceremony takes place on Thursday 28th November 2024 12 to 3pm in the Lighthouse Cinema Dublin.

7.4 Planet Youth

(Mon 23 September, 2024) – Representatives from Tipperary County Council, Tipperary Children and Young People's Services Committee (CYPSC) and the Local Community Development Committee (LCDC) welcomed Minister of State for Mental Health and Older People Mary Butler TD to Technological University of the Shannon (TUS) Thurles where she officially launched two new mental health initiatives: the *5 Ways to Wellbeing project* and *Planet Youth Tipperary*. Wicklow who are partners held their launch on 7th October

34 Schools have fully engaged, signed up for training and we have held 2 Question and Answer sessions with the school contacts. School packs have been prepared with support guide and this will issue to all the schools. The survey will take place between the 4th and 15th November. It is the intention to engage with those not in Employment, Education, Training (NEETS) with the support of the Youth Services in the County. Our numbers will be combined with Wicklow to achieve a school report and for the first time Galway Mayo Roscommon will also engage with this cohort.

Mairead Ryan updated the members on the CLAR 2024 Measure 1 Funding. This information is provided for information only, the LCDC does not have a function in determining or recommending this grant funding.

2024 CLÁR Measure 1 Developing Community Facilities and Amenities – Funding Announcement

CLÁR (Ceantair Laga Árd-Riachtanais) is a targeted investment programme for rural areas that aims to provide funding for small infrastructural projects in rural areas that have experienced significant levels of de-population.

On 7th October 2024, funding of €522,397 was awarded to 13 projects across the county by Minister Heather Humphreys. The details are as follows:

The 2024 Dormant Accounts Fund Action Plan includes the provision of €150k to support LGBTI+ Community Organisations.

Under this measure, funding will be allocated to help provide services to LGBTI+ organisations nationwide targeting marginalised people experiencing exclusion on account of their LGBTI+ identities.

Funding will be available to organisations locally for the provision of services that will include:

- Extending drop-in hours, developing information and guidance tools, holding additional community events
- Delivering LGBTI awareness/sensitivity training in healthcare settings, businesses, schools etc.
- Providing outreach support
- Providing sporting/physical activity programmes to promote inclusion, community participation, health and wellbeing

The closing date was C.O.B., 4th October 2024.
