6. LEADER 2023-2027

6.1 Update on IEC Induction

Marie Cox advised the members that 23 out of the 24 positions on the IEC had now been filled and an extensive training programme with the new members was held by the NTDC and STDC last week. Michael Murray informed the group that there was huge interest in the IEC.

6.2 IEC Terms of Reference

Marie Cox updated the members on the IEC current terms of reference which had been emailed to the Sustainable Communities Subgroup with no feedback arising, and asked them to ratify same. This was approved on the proposal of Mike Edwards and seconded by Derval Howley.

Quality of Life

7.1 Healthy Ireland Fund (HIF) 2023-2025 update

Fiona Crotty updated the members on the Healthy Ireland Fund 2024. All financial returns have been submitted to Pobal for 2023 together with all queries regarding the spend for 2023 and payment of funding for 2024 has been paid over. The SLA has been signed with Pobal and Tipperary County Council for the funding for 2024.

Some activities and programmes from the partners are underway and will continue throughout the summer. Meetings have taken place with delivering partners for the fund to outline spend for 2024 and activities planned for the fund. Updates will follow.

Bealtaine festival took place for the month of May and is Irelands National festival which celebrates the arts and creativity as we age. Tipperary County Council library service had lots of different events and programmes across the County library network for the month, Healthy Tipperary supported a talk by former New Zealand rugby player, Brent Pope in Littleton on 27th May. Brent Pope is one of Irelands leading Mental health advocates and discussed the whole subject around mental health and the "elephant in the room campaign" The talk was very personal account of Brent's own struggles with mental health and how important it is that everyone of all ages looks after their mental health. This event saw 100 people register online, it was a free event and over 80 people attended on the night with a Q&A session afterwards and a chance to have a cup a tea and meet Brent Pope.

7.2 Healthy Communities Clonmel

Substance Misuse Action Plan

The Substance Use Subgroup are meeting today (Monday 24th June) and the key priorities and actions are to be identified from the coded Community Conversations.

Planet Youth Project

Fiona Crotty advised all to save a date in their diary for the 23rd September which is the Planet Youth Launch date.

Youth Social Prescriber Pilot

LDO is working with Barnardos on a pilot for youth prescribers for 6- to 10-year-olds.

Drugs Rehabilitation CE Scheme

STDC have specified an interest in becoming an implementing partner for the Drugs CE scheme in Clonmel. A meeting was held on 22nd May with Community Employment, STDC, SERDATF and LDO to discuss the scheme. STDC and Slaintecare LDO have been invited to visit Carlow Special Drugs CE scheme on the 11th July.

Fiona Crotty updated the members on the following:

7.3 Tipperary Age Friendly

The inaugural Age Friendly Ambassadors' Day was held in Slane Castle on 23rd May 2024. This is an annual awareness initiative launched by Age Friendly Ireland to champion positive ageing. John Lonergan is the Tipperary Age Friendly Ambassador. These ambassadors hold honorary positions to promote age-friendly practices within their local authority areas and support local Age-Friendly Programmes across Ireland. This includes countering ageism and prejudice by promoting positive age awareness.

Tipperary Older Peoples Council

The Executive of Tipperary OPC held their meeting in TUS. The OPC gave their feedback on the annual convention, took on tasks in preparation for the annual EXPO and planned for events later in the year around dementia awareness and addressing loneliness as a focus group

Tipperary Age Friendly Alliance

The Alliance quarterly meeting was held in Thurles on May 30th. It was agreed that feedback on the implementation Plan 2024-2025 would be conducted by partners at future meetings. Dr Marie Walsh from TUS gave a presentation on the project with Tipperary Age Friendly and Day Care Centres in Tipperary with an agreed action for Age Friendly to facilitate a networking meeting with North and South Day Care Centres attended by members of the Alliance and strengthening the community connections with the local day care.

Tipperary Age Friendly EXPO 2024 - 20th June 2024

On Thursday 20th June, we hosted our annual EXPO. We had 64 information stands and a wide range of talks including a talk by John Lonergan, Tipperary Age Friendly Ambassador, Ciara Farrell, Age Friendly Ireland, Richie Molloy, Family Carers Ireland, John Lynch Solicitor, Aldo Mattassa UPMC, Stairlifts Plus, Fraudsmart, Circle of Friends, Affordable Life in Homecare and Irish Cancer Society with Michelle Lonergan. Musical interludes were performed by Rockwell Music Academy and Templemore Active Retirement and music for the dancing in the afternoon was provided by John McCormack.

Eoin Wolahan congratulated Fiona and her team on a very successful day.
