Mr. Anselm McGowan, District Administrator, commenced the meeting with the meeting prayer as Gaeilge in recognition of Seachtain na Gaeilge. The Cathaoirleach, Councillor John Crosse, welcomed everyone to the March Municipal District meeting and commenced the meeting.

1.1 Disclosures/Conflicts of Interest

There were no matters notified to the Meetings Administrator.

2.1 Minutes of February Meeting of Tipperary-Cahir-Cashel Municipal District held on 24th February, 2025

The minutes of the Tipperary-Cahir-Cashel Municipal District February meeting held on 24th February, 2025 were adopted on the proposition of Councillor Roger Kennedy seconded by Councillor John O'Heney.

Matters arising from the minutes

There were no matters arising.

3.1 Housing Directorate Report

The Cathaoirleach welcomed Deirdre Flannery, A/Administrative Officer, Breda Ryan, A/Administrative Officer and Shaun Lonergan, Executive Engineer, Housing Section to the meeting. The team thanked the Cathaoirleach and taking their report as read were available to take questions from the Members.

Councillor Mary Hanna Hourigan requested details of the Department allocation for property acquisition including how much and what type of properties can be purchased. Councillor Murphy requested clarification in relation to Mountain View Drive, Cahir and what was meant by re-engaging in planning. She also requested an update in relation to the housing development at Clogheen and details of how many houses are included in the Energy Efficiency Retrofit Programme. Councillor McGrath also supported Councillor Murphy in relation to Mountain View Drive and requested the breakdown of house types for the development in Clogheen. She also referred to the approved housing list and requested that more details be provided including house type and breakdown of need. Councillor Burgess requested an update in relation to the houses at Longfield, Boherlahan and requested clarification that they will be for elderly and vulnerable applicants. He also commented that the Retrofit Programme is not fit for purpose and the programme should focus on particular estates with additional capacity to target individual houses in areas where no reletting repairs or upgrades have been carried out. Councillor Burgess requested an update on the social housing units with Tuath and when will the next phase of Coopers Lot be available on CBL. He also requested clarification in relation to Tenants in Situ acquisitions and is aware of cases of tenants with Notice to Quits and the landlord is agreeable to sell the house to the Council. Councillor Browne referred to an issue that was raised at the recent SCP meeting where it was noted that other Districts were receiving greater details on the vacant houses list. Councillor Browne also commented that some tenants are reluctant to have upgrades carried out under the Retrofit Scheme due to the air to water system and problems experienced by some due to the recent severe weather event. He also noted that tenants are making repair requests and being told its the tenants responsibility. He asked if the budget could be increased to cover small repair requests. Councillor Browne also asked if small families could be allocated three bedroom properties because with growing families they will need a larger house in time. Councillor Kennedy asked if payments of housing grants could be made directly to contractor as some contractors are not being paid in full. Councillor McGrath asked that a particularly focus would be put on the Tenant in Situ Scheme to purchase houses for disability purposes because the need is greater.

In response Ms Flannery confirmed that they are currently waiting for a Department Circular in relation to the Tenant in Situ Scheme and she believes

the focus will be on homeless and disability but very exceptional cases. She confirmed that a clear message needs to get out to landlords that the Council will not be buying houses. Regarding, Councillor Browne's query which was raised at the SPC, housing is not in favour of identifying vacant houses due to the risk of squatters and vandalism. She also confirmed that houses are allocated based on need and have regard to the policy and the age of the children. However, there would be a common sense approach if a couple with one child applied they would be considered for a three bedroom property.

Ms Ryan confirmed that grants are paid to the applicant and the onus is on the applicant to find a contractor to carry out the work. The District Director advised that the contract is between the tenant and the contractor and if the Council was involved, a contractor would be subject to the Council's health and safety criteria. Councillor Hanna Hourigan advised that she has dealt with other Council's like Limerick who pay grants directly to the contractor.

Mr Lonergan confirmed that there was Section 179A approval for the construction of 45 new houses at Mountain View Cahir, however the commencement was delayed because of Uisce Eireann and the Section 179A planning approval is expiring. Therefore, to keep the project moving the Housing Team will now apply for Part 8 approval. They have completed the tender process and subject to Part 8, hope to be on site in Q3 2025 with an 18 month build time. He also confirmed that the construction of 15 houses in Clogheen will also be going to Part 8 shortly and he will circulate details of the house type breakdown after the meeting. also agreed to circulate further details in relation to the house types of Wallors Lots and Longfield Boherlahan after the meeting. Mr Lonergan advised the Members that there are 71 Houses across the County that have been identified for Energy Efficiency Retrofit Programme and 23 are in this District. He confirmed that some house types are very difficult to bring up to a B2 standard and all upgrades include air to water, insulation and windows upgrades. confirmed that the next phase of Coopers Lot which includes 12 houses will be ready by Q2 2025.

Councillor McGrath and Councillor Murphy expressed their disappointment in relation to the delays with the development at Mountain View Drive and referred to the very positive engagement with the public. Councillor Browne requested that more money would be made available for repairs because some tenants can't afford repairs because the house has deteriorated over time and suggested a loan scheme. Councillor Kennedy requested an update in relation to a repair request he made in relation to water running down the inside wall of a tenants house.

In response Ms Flannery advised that there is a central budget for repairs and a budget is made available once a request is made. She commented that this is a restricted budget and the housing section has to be consistent and that is why the handbook is referred to in the response to tenant requests.

The Cathaoirleach thanked the Housing Team.

3.2 Consider the Tipperary Festivals & Events Grant Scheme Allocations 2024.

The Cathaoirleach advised the Members that due to the brave decision last September to raise the LPT there is now more money for Festival & Events, Tidy Towns and noted that 64% (€230,000) is going back to the community through the grants being discussed at the March meeting.

On the proposition of Councillor Declan Burgess, seconded by Councillor Roger Kennedy, the Tipperary Festivals & Events Grant Scheme 2025 allocations were agreed as follows:

3.5 District Engineer's Report

Mr James Swords, District Engineer advised the Members that the road strengthening and recycling had started last week. He confirmed that the Bridge works commenced and he hopes to bring the Red Roads before the Members for approval at the April meeting.

Councillor Kennedy referred to the Rossmore Road to Thurles and he confirmed that this District did a great job on their section and Thurles Municipal District did a great job on their section however there is a 150m stretch in between, that hasn't been upgraded. Councillor Burgess also wanted to support this. Mr Tim Kilmartin, Local Area Engineer advised that there was a particular issue with cows crossing the road and that area couldn't be resurfaced at the time due to poor Councillor Kennedy also referred to a number of cooperation from the farmer. near misses at the school crossing at the Green, Cashel and requested more training and more signage. Councillor Crosse wanted to compliment the roads team on the work to the footpath in Bansha and he asked if it could be extended to the next cross. He also wanted to thank Tim Kilmartin and Paddy Crowley, Active Travel on the improvement works in Emly. Councillor Burgess requested a solution to the junction or Friar Street and Dualla Road and he also asked for a review of the roundabout design at Bregaun. Councillor O'Heney noted the safety works are due to start at Shronnell in September and he also requested that works be carried out in Lattin village.

In response the District Engineer confirmed that line marking is required at the Green and he also confirmed that work on a design for the Dualla Road/Friar Street roundabout will commence this year with funding from development levies. He also confirmed that they will contact the designer of the Bregaun Roundabout and request them to carry out a review. He confirmed that next month work will commence on safety improvement works at Mitchelstown Road, Cahir and the Active Travel team have plans to trial the Super Valu Roundabout.

3.6 District Administrator's Report

The District Administrator's Report was circulated to the Members with the agenda and the District Administrator advised that he was available to take questions. There were no questions from the Elected Members.
