It was proposed by Councillor J. Ryan, seconded by Councillor M. Lowry and resolved:

"That the Thurles Municipal District Town Pollinator Plan and Grass Mowing Plan be approved for public consultation on Saturday 10th May, 2025."

4.1 Update from Planning and Development/Emergency Services

Shane Grogan, A/Senior Executive Officer, Jonathan Flood, Senior Executive Planner and Teresa Kiely, Administrative Officer, Planning and Development/Emergency Services were in attendance for the meeting. A Planning Briefing Note dated April 2025 for Thurles Municipal District was circulated to the members in advance of the meeting and taken as read.

The Members raised the following queries:

- Has there been any update from Uisce Eireann (UE) regarding the taking-in-charge of Developer Provided Infrastructure (DPI) estates, such as Hayfield Manor, Thurles.
- Have there been any submissions for 2025 under the R2LT
- What type of application will be made in relation to Thurles and the URDF Call 3 which deals particularly with dereliction.
- Has there been any update regarding the taking-in-charge of Orchard Court, Templemore. There are elderly people living in the estate, there is no lighting and issues in the estate regarding burglaries and cars being broken into.
- Is there an age limit for recruitment into the Emergency Services Fire section, and if so is the age set locally or nationally?

Replies to queries raised was as follows:-

- There has been no update from Uisce Eireann (UE) regarding the taking-in-charge of Developer Provided Infrastructure (DPI) estates.
- 23 submissions have been received under the R2LT, 9 of which relate to lands in Thurles MD. The submissions are currently being examined.
- 77 applications countywide under the RRDF Call3, 13 of which apply to Thurles. 6 of these applications have been progressed and 7 are currently under negotiations.
 - None of the €5m allocated under this scheme has been spent to date but TCC are actively looking at properties and making developers aware of the scheme.
- Uisce Eireann (UE) have been allocated responsibility for dealing with DPI estates nationally. An Inter Government Committee has been established to liaise between the Government and Local Authorities and

Orchard Court estate cannot be taken-in-charge until all issues in relation to DPI estates have been resolved.

UE do not have the financial resources to address the DPI estates nationally and it will be several years before this issue is resolved at a national level.

 The age limit for recruitment into the Emergency Services Fire section is likely set nationally, however, the MD will seek clarity from HR.

5.1 To formally approve grants in the following categories:-

The Members raised the following queries:-

- Will the Tidy Towns Committees, from hereon, be insured through Irish Public Bodies (IPB) and what will the procedure be?
- The grant of €700 awarded to burial ground committees is very small, especially considering that most of these graveyards are council owned. The level of work undertaken by burial ground committees is vast, including, amongst other things, grass cutting, wheelie bin management, and insurance.

Replies to queries raised was as follows:-

- A new national initiative has been introduced whereby Irish Public Bodies will now cover insurance for Tidy Towns Committees across Ireland.
 - Thurles MD are currently in the process of writing out to the Tidy Towns Committees to inform them that the IPB will provide their insurance from hereon and the IPB will engage directly with the committees.
- The burial ground grant is awarded by Thurles Municipal District on behalf of Environment Section. The amount of the grant is a countywide decision.
 - Cllr. Kennedy should submit a specific request to the MD Director requesting that the level of grant be examined and this will be examined in conjunction with the 2026 TCC budget.

It was proposed by Councillor S. Ryan, seconded by Councillor W. Kennedy that:-

5.2 District Engineer's Report

An updated District Engineer's Report for the MD was circulated to the Members in advance of the Meeting and taken as read.

The Members raised the following issues:-

- Are the MD responsible for trees in housing estates as some street lighting is being blocked by overgrown trees such as in Willowmere Drive and Cluain Glás, Thurles.
- The lights at the pedestrian crossing at Abbey Road, Thurles are still not working.
- Road markings are needed at the roundabout on the Mill Road/Kickham Street junction as the markings have completely faded.
- Can additional car parking spaces be installed at Cabra Court, Thurles
 as there are not sufficient car parking spaces in the estate resulting in
 drivers parking their cars on the green area.
- When will the white lining and vertical indicators repair/replacement programme commence.
- A redundant traffic island on the N8 is prohibiting homeowners from driving directly into their houses and they must go up the road and turn around in order to gain access to their homes.
- How will the Local Improvement Scheme (LIS) be allocated in relation to new applicants when the scheme opens in July.
 Should TCC suspend the new scheme for the moment while we work on the list of applicants we already have.
- Cllr. S. Ryan requested that it be noted that at no point did he suggest at the March Monthly Meeting that the barrier outside Supermacs, Thurles was damaged by bad HGV drivers.
- Can anything be done to address the issue of water lodging outside homeowner gates and splashing into their yards

Replies to queries raised were as follows:-

- The MD do generally not remove any trees unless they are dangerous or are blocking street lighting.
 The issue of trees blocking street lighting at Willowmere Drive and Cluain Glás, Thurles will be investigated.
- The MD are still waiting on the ESB to make the connection for the lights at the pedestrian crossing at Abbey Road, Thurles. The MD will contact the ESB again to try and expediate the matter.

- The faded road markings on the roundabout at the Mill Road/Kickham Street junction will be investigated.
- Additional car parking spaces were installed at Cabra Court, Thurles a
 few years ago and currently there is no available budget to install any
 further spaces. Furthermore, the MD must comply with planning
 regulations whereby a certain percentage of the land must be dedicated
 to green space area.
- The white lining and vertical indicators repair/replacement programme
 has commenced and will be ongoing over the next few weeks. Any
 proposals of areas that may need to be addressed should be submitted
 to the MD.
- The issue of a redundant traffic island on the N8 that is prohibiting homeowners from driving directly into their houses will be examined, however, funding for former national roads will not cover the removal of the island.
- TCC has submitted its list of eligible applications under the LIS scheme
 to the Department for approval.
 The LIS scheme will be advertised later this year and it is important
 that existing applicants are not disadvantaged over new applicants.
 TCC have never ignored a call for the LIS Scheme previously, however,
 Roads Section will revert back to the Members before any decision is
 made.
- If the water that is lodging outside people's gates is coming from the road then it is the responsibility of the MD. The specific area in question can be investigated.
